When: Friday and Saturday, May 20 and 21, 1994 (begins Friday afternoon following TOA's Annual Conference)

Where: The Forum (Inter-Continental) Hotel - Chicago, II.

- Why: To provide <u>experienced</u>, <u>practicing ombudsmen</u> with an opportunity to test and stretch their skills in a safe and \_\_\_\_\_\_ confidential environment.
- How: Ombudsman 303 is a highly interactive 10 hour workshop dealing with complex situations. Participants will increase their knowledge of negotiation theory; gain experience in case analysis from a neutral's perspective; and, using role play situations, develop strategies and techniques to work through tough cases dealing with harrassment, threat of violence, and a difficult manager.
- Who: Participation is limited to 39 ombudsmen who have had a minimum full time equivalent of two years practice as a designated neutral.
- Cost: Ombudsman 303 registration fee is \$225 for TOA members, \$300 for non-TOA members. (U. S. Dollars)
