1. TOA Booklets

Jayne Vicelich reported that authors of titles, outstanding, have reported that they are running late on their commitments as a result of constraints resulting from the upcoming North American Omubuds conference. However, on a positive note, Howard Gadlin reported that he may have his booklet ready for proof review by mid May.
