1. Mail Service

Fahnestock was unable to confirm the inadequacy of the mail service reported in the minutes of the Group Leaders' Meeting of May 25, 1953. The concensus of opinion was that the service has improved greatly in the past few weeks.

A discussion of the Standards resulted from a proposal of the Lincoln Steering Committee that a laboratory-wide Lincoln Standards Committee be set up. It is expected that the Committee will rely heavily on the work already done in Division 6. We should be prepared to name a Division 6 representative for the Lincoln Laboratory Committee. The names of Fallows, Watt and Morley were proposed. The choice should be based, to some extent, on what type of people the other Divisions are going to appoint. Fahnestock will consult Vitale to see if he has further information.

It was generally agreed that Division 6 needs at least two kinds of Standards, namely, 1) for general laboratory use and 2) for Whirlwind II. We should avoid duolication of paper work and indicate on the sheets under which category the particular standards comes. Taylor was anxious to have standards expanded to include such things as basic circuits.
