10-1-A Salary Review

Taylor indicated figures not yet available from the Director's Office but urged early preparation of ladders. Proctor urged the preparation of justification of individual cases. Discussion indicated the need for reproductions of the Personnel Office cards. Question was also raised concerning access to salary information.

10-8-A Open House
